CARIBBEAN AND INTERNATIONAL SPEAKERS SLATED FOR THE ICAC 35th ANNUAL CONFERENCE IN JUNE

The 35th Annual Conference of the Institute of Chartered Accountants of the Caribbean (ICAC) to be held on June 22-24, 2017 at the Marriott Hotel, in Georgetown, Guyana will feature an impressive line-up of regional and international speakers.

The 2017 Conference will be hosted by the Institute of Chartered Accountants of Guyana (ICAG) under the theme, "New Horizons - Charting the Course Together", and will focus on empowering business, finance and accounting professionals with the knowledge and strategies to advance the development of the region. Ian Ball, Chairman of CIPFA International and Chair of the Audit Committee for the financial statements of the New Zealand Government, who has served as an advisor on government accounting matters will speak on the topic, "Public Financial Accountability - Getting It Right" and Brian McEnery, President, Association of Chartered Certified Accountants (ACCA), will speak on the topic, "Future Proofing the Talent Pipeline – Accounting for Generation Next".
